Dear All,

The Maharashtra Medical Council (MMC) would like to bring to your attention towards revised fee structure of applications under the MMC CPD guidelines. As you are aware, credit point is one of the important criteria for renewal as CPD evaluates physicians continuing competence, also provides updates in scientific research, new advances clinical skills necessary for improving patient care.

Maharashtra Medical Council has CPD platform for regulation of CPD. Council implemented CPD program and prepared CPD guidelines in the year 2010. Since then, the Council has passed resolutions in council meetings from time to time, making amendments to the CPD guidelines. In respect of these CPD guidelines, the Council has now taken a policy decision with consultation of Indian Medical Association, Maharashtra State to revise the fee structure of applications under the MMC CPD guidelines.

Kindly note that the revised fee structure will come into effect on 26th January 2025: -
